Property Owners may receive up to two (2) standard transponders free of charge every three years. Additional standard transponders may be purchased at the price of \$25 each. You have the option of paying for the additional Transponders by check or money order when they are issued, or you may be billed for them on your next quarterly assessment statement.

Property Owners and Residents must re-register their Transponders every two years. The HOA office will notify when it is time to re-register. Failure to re-register as required may result in the deactivation of your Transponder until such time as you have completed the re-registration process.

Use of a Transponder for access into the community is a privilege. All CC&R provisions, Community rules, policies and regulations apply. You agree to abide by posted speed limits and designated parking spaces. Violations may result in suspension or revocation of your Transponder and may result in fines and other penalties as may be allowable under Nevada Law. You agree to timely pay such fines.

I understand that vehicle insurance is required to obtain and maintain a Transponder. I confirm that I have such insurance for all vehicles and golf carts registered above and agree to maintain such insurance while I have a Transponder.
